Disadvantaged Business Enterprise (DBE) % Requirements	Per TxDOT, the ASSIGNED DBE GOAL for the Great Springs Project Request for Proposals is based on the project's Federal funding, type of work, location, overall and item cost estimate values, subcontracting opportunities, certified DBE firms in vicinity of the project location, and size of the project, TxDOT hereby assigns a race-conscious DBE goal of FOUR- AND ONE- HALF PERCENT (4.5%) for this project proposal.
